MINUTES The Minutes of the meeting of November 11, 2019 were approved as submitted.

UPD - Lee Arnold reported that the snow sticker registration went well. There were 166 calls for service last month, including 3 burglaries in Cardiff, and 2 felony arrests for those burglaries. The Graffiti Enforcement Task Force has \$31,000 left to spend through June 30, 2020. Lee would like to see the Brighton Round About used fully to improve traffic flow. He noted that lack of snow tires continues to be a traffic issue. The rental car companies are the worst offenders. Ed Tohill will be the new Canyon Patrol Day Sergeant (801.759.3028).

Conditional Use - The Council unanimously recommended that Richard Dorney's application for a short term rental be approved. It was also recommended that he post a sheet of Short Term Rental Guidelines developed by BCCA, including a Roofalanche warning that was added to the Rental Guidelines. Brooke Derr and Don Despain abstained from the vote.

BCCA Elections – The following people were unanimously elected to serve as BCCA officers:

President-Barbara Cameron; 1st Vice-President-Don Despain; 2nd Vice-President-Tom Loken; Secretary-Jeanette Sawaya; Treasurer-Greg Hatch; Doug Fry-ACCT Representative.

The following people were unanimously appointed to serve on the BCCA Board of Directors:

Members-At-Large: Cyle Buxton, Carolyn Keigley, and Alternate John Anderson

Ski Resort Representatives: Randy Doyle (Brighton Resort), and Kim Mayhew (Solitude Mountain Resort)

ACCT - Doug Fry handed out a comprehensive update on 2019 ACCT meetings, and noted what an active and interesting group it is. He urged everyone to attend the Annual ACCT Training on January 18.

Town of Brighton - Carolyn Keigley reported that the Town has rented 2 office spaces at Fire Station #108. The Town meetings will be at 6:30 pm on the 1st Monday of the Month in January, February, and March, then change to the 1st Tuesday of the Month in April-December. Jenna noted that the Town is close to launching a website (Brighton.utah.gov). Attorney Polly McLean is writing the Town's Municipal Code. Nate Rockwood was hired to help with budget administration.

Other Business - Steve Jorgensen noted that we need to re-evaluate BCCA's position in the canyon. We should try to recruit more secondary homeowners to serve with BCCA. Jim Keener asked about the effectiveness of the new Solitude parking situation. Randy reported that the busses are full, and they run 4 extra busses at night to be sure all skiers are out of the canyon on time. Solitude's lot is full, but many people park on the highway. Lee Arnold reported that they have been towing cars (the tow fee is around \$350).

Resort Updates - Randy Doyle reported that the Brighton Parking & Travel App is up and running. He urged residents to follow the parking attendants' directions so that the lot can be filled efficiently. They have 22 Parkies, and usually post a couple at Redman Campground on busy days to warn people to turn around if there's no parking. Only a few actually do. Overnight parking in the Brighton Store lot causes big headaches for plowing. If you need to park there, please arrange it with the Brighton crew before parking. Carolyn and Greg will send out an email to the Forest Glen HOA list about the Store parking request. Don Despain suggested that a Shuttle Sign be posted in the Store lot to show where the bus can be boarded. Randy noted that January will be very busy. UDOT will fly drones in the canyon on Monday, January 20 for their EIS study. Fireworks are on January 24!! The Youth Ski League Race is on January 25.
